ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF OLD WARWICK ROAD, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Old Warwick Road, Lapworth, between points approx. 20m either side of the bridge, to vehicular traffic. The closure is required for works on and around the bridge, 22.00hrs – 05.00hrs nightly.

The Order will commence on 15 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 18 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Old Warwick Road, Packwood Lane, Stratford Road, Liveridge Hill, Birmingham Road, High Street, Warwick Road, Blackford Hill, Whitley Hill, Henley Road, The Green, Lye Green Road, The Cumsey, Shrewley Common (and vice versa).

TEMPORARY CLOSURE OF SHEPHERDS LANE, GREAT PACKINGTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Shepherds Lane, Great Packington, between its junctions with A45 and Maxstoke Lane, to vehicular traffic. The closure is required for gully repairs and associated works.

The Order will commence on 14 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

A One-way diversion route is available via A45 South, A45 North, Maxstoke.

TEMPORARY CLOSURE OF CHAPEL LANE, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing Chapel Lane, Lapworth to vehicular traffic. The closure is required to facilitate works for renewal of a boundary box.

The Order will commence on 2 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 4 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Chapel Lane, Chessetts Wood Road, Darley Green Road, Bakers Lane (and vice versa).
