ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF VICARAGE HILL, WOOD END

Warwickshire County Council proposes to make a Temporary Traffic Order closing Vicarage Hill, Wood End from a point outside Glebe Farm, to vehicular traffic. The closure is required for underground utility works. The Order will commence on 22 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 24 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Vicarage Hill, Broad Lane, Tom Hill, Knowlebury Cross, Doctors Hill, The Green (and vice versa).

TEMPORARY CLOSURE OF C22 LAPWORTH STREET, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing C22 Lapworth Street, Lapworth, from Jct. Old Warwick Road to Jct. Catesby Lane, to vehicular traffic. The closure is required for drainage works.

The Order will commence on 21 October 2019 and will last for a period of 18 months, or until the works anticipated that the works will be completed by 25 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF D5022 PIG TROT LANE, DANZEY GREEN

Warwickshire County Council proposes to make a Temporary Traffic Order closing D5022 Pig Trot Lane, Danzey Green, from Jct. Danzey Green Lane to Jct. Kemps Green Road, to vehicular traffic. The closure is required for carriageway patching and associated works.

The Order will commence on 21 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 08.00 and 16.00 on 21 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Danzey Green Lane, Well Lane, The Green, Vicarage Hill, Broad Lane, Umberslade Road and vice versa.
