The Metropolitan Borough of Solihull (Chester Road, Castle Bromwich) (Temporary Road Closure) Order 2019

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow gas replacement works to be undertaken in safety. **Chester Road, Castle Bromwich** (near its junction with Water Orton Road) will be closed from **8am on Thursday 3 October 2019 to 5pm on Friday 18th October 2019** (24 hours a day). Alternative routes for traffic will be signed via Bradford Road, The Green, Chester Road and Water Orton Road. Vice versa for the other direction. Informatory warning signs will be deployed, not less than seven days before any particular road will be closed. Access for emergency services **will** be maintained through the restriction. Pedestrian and vehicle access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of the closure. The Metropolitan Borough of Solihull (School Lane to Union Road, Solihull) (Temporary Footpath Closure) Order 2019

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that pedestrian traffic should be restricted or prohibited to allow footpath reconstruction works to be undertaken in safety. **Footpath linking School Lane to Union Road, Solihull, B91 3EF** – will be closed from (8am) on Monday 14th October 2019 to (4pm) on Friday 1st November 2019. Alternative routes for pedestrians will be signed via School Lane, Grove Road, Lode Lane, Warwick Road and Union Road. Vice versa for the opposite direction. Informatory warning signs will be deployed, not less than seven days before any particular footpath will be closed. Access for emergency services **will not** be maintained through the restriction. The Metropolitan Borough of Solihull (Station Road, Dorridge) (Total Prohibition and Restriction of Waiting) (Experimental) Order 2019

Notice is hereby given that the Council have made the above mentioned Order under the provisions of Sections 9 and 10 of the Road Traffic Regulation Act 1984 as amended, and all other enabling powers. The Order shall come into effect on **15 October 2019** and will remain in force on an experimental basis for a maximum period of up to 18 months. The general nature and effect of the Order will be as follows:- **Experimental Total Prohibition of Waiting (At Any Time)** Station Road (eastern side) – from a point approx 35m from Grove Road/Widney Road (roundabout) south westwards for approx 32m. **Experimental Restriction of Waiting (Monday to Friday – 8.30am to 9.30am and 3.00pm to 4.00pm)** Station Road, Dorridge (eastern side) – from a point approx 119m south west of Grove Road/Widney Road (roundabout) south westwards for approx 90m. Station Road, Dorridge (western side) – from a point approx 373m south west of Grove Road/Widney Road (roundabout) south westwards for approx 47m. Station Road, Dorridge (western side) – from a point approx 439m south west of Grove Road/Widney Road (roundabout) south westwards for approx 42m. In due course, the Council will consider whether or not the provisions of the Experimental Order should be continued in force indefinitely. Within a period of six months from the Order coming into force, (or if any or all of the Order provisions are varied or modified by another Order, from the date of that variation or modification Order, whichever is the latest), any person may object to the making of the Order to continue on a permanent basis.
