ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

SMALL LANE, MALTHOUSE LANE & VALLEY ROAD, EARLSWOOD

Order Effect: Road Closed to vehicular traffic.

Reason for Order: utility works.

Order Commences: 28 October 2019 for up to 18 months.

Anticipated Completion Date: 1 November 2019.

Access & Diversion: Small Lane, Poolhead Lane, Broad Lane, Earlswood Common, Springbrook Lane, Malthouse Lane (and vice versa).

SPRING LANE, LAPWORTH

Order Effect: Road closed to vehicular traffic between the junctions of Wharf Lane and Church Lane.

Reason for Order: Works for a boundary box renewal.

Order Commences: 29 October 2019 for up to 18 months.

Anticipated Completion: 31 October 2019.

Access & Diversion: Spring Lane, Wharf Lane, Old Warwick Road, Church Lane (and vice versa).

DOCTORS HILL, TANWORTH IN ARDEN

Order Effect: Road Closed to vehicular traffic from The Green to Butts Lane.

Reason for Order: the renewal of a water main.

Order Commences: 11 November 2019 for 18 months.

Anticipated Completion Date: 17 January 2020.

Access & Diversion: Doctors Hill, The Green, Vicarage Hill, Broad Lane, Tom Hill, Knowlebury Cross (and vice versa).

D5046 PACKWOOD LANE & D5045 GROVE LANE, LAPWORTH

Order Effect: Roads closed to vehicle traffic, in phases, as follows:

1. Packwood Lane from jct of Rising Lane to jct of Grove Lane.

2. Grove Lane from jct with Packwood Lane to jct with the B4439 Old Warwick Road.

Reason for Order: Carriageway patching and associated works, 09.30 – 15.30.

Order Commences: 14 November 2019 for up to 18 months.

Anticipated Completion: as indicated on site.

Access & Diversion: 1. Packwood Road, Darley Green Road, Norton Green Lane, A4141, Rising Lane and vice versa.

2. Packwood Lane, B4439 Old Warwick Road and vice versa.

Access for residents and businesses to be maintained where possible.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
