The Metropolitan Borough of Solihull (Wootton Lane, Balsall Common) (Temporary Road Closure) Order 2019

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow BT telecommunication apparatus works to be undertaken in safety. **Wootton Lane, Balsall Common, CV7 7BS** – closed from outside Brooklands Farm for a distance of approximately 230 metres in a south westerly direction from **(8am) on Monday 9th December to (6pm) on Friday 20th December 2019**. Alternative routes for traffic will be signed via Barston Lane, Balsall Street, Station Road and A452 Kenilworth Road. Vice versa for the opposite direction. Informatory warning signs will be deployed, not less than seven days before any particular road will be closed. Access for emergency services **will** be maintained through the restriction. Pedestrian and vehicle access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of the closure.
