The Metropolitan Borough of Solihull (Cuttle Pool Lane, Knowle) (Temporary Road Closure) Order 2020

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow the cable and jointing works to be undertaken in safety. **Cuttle Pool Lane, Knowle** will be closed from the junction of the Kenilworth Road to the junction of Temple Lane from **Monday 9th March to Sunday 15th March 2020 (0800hrs to 1600hrs daily)**. Alternative routes for traffic will be signed via B4101 Kenilworth Road and Temple Lane. Vice versa for the other direction. Informatory warning signs will be deployed, not less than seven days before any particular road will be closed. Access for emergency services will be maintained through the restriction. Pedestrian and vehicle access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of the closure.
