The Metropolitan Borough of Solihull (Knowle Village Centre) (20mph Speed Limit) Temporary Traffic Regulation Order 2020

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that in the interests of public safety during the COVID-19 Recovery Phase the following traffic management arrangements will apply: **A4141 Warwick Road/High Street** – from a point approximately 52m north west of Lodge Road, running in a south easterly then southerly direction for a distance of approximately 600m to a point adjacent to 1706 Warwick Road, Knowle. **B4101 Wilsons Road** – from A4141 High Street to B4101 Kenilworth Road. **Kenilworth Road** – from A4141 High Street to a point approximately 20m east of B4101 Wilsons Road. **B4101 Station Road** – from a point approximately 15m east of St Johns Close, running in an easterly direction to A4141 High St/ Warwick Rd. **Lodge Road** – from Dell Farm Close to A4141 Warwick Road/High Street). **Nature of restriction:** Temporary maximum 20mph speed limit. **Date(s) when restriction will apply:** 9 July 2020 until 4 September 2020. **Times when restriction will apply:** 24hrs on all days. **Reason for restriction:** Public safety during COVID-19 Recovery Phase. **Diversion routes:** Not applicable. None of the restrictions shall apply to Fire and Rescue, Ambulance, Police, Military or Special Forces purposes when responding to emergencies.
