The Metropolitan Borough of Solihull (Various Roads, Solihull – Covid-19 Recovery Phase) (Temporary Traffic Regulation) (Amendment No. 1) Order 2020

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that in the interests of public safety during the Covid-19 recovery phase and to re-prioritise the road network space, The following traffic management arrangements will continue in force from Friday 4 September 2020 until Monday 11 January 2021 or removed prior to this if they are considered no longer necessary. Temporary Prohibition of Motor Vehicles – A34 Stratford Road, Shirley Service Roads fronting Baptist Church – 120 Stratford Road (west side); fronting 192 - 206 Stratford Road (west side); fronting 266 - 268 Stratford Road (west side); fronting 179 - 201 Stratford Road (east side); and fronting 241 - 271 Stratford Road (east side). Temporary Suspension of On-Street Waiting/Loading – A34 Stratford Road, Shirley Service Road all bays on eastern side directly fronting 171b – 177b Stratford Road; and all bays on western side directly fronting 150-156 Stratford Road. Temporary One Way Traffic – Solihull Town Centre Homer Road one way working in a north westerly direction between Herbert Road and Prince's Way (north westbound carriageway only); and New Road one way working in a westerly direction (contraflow) along the eastbound carriageway between Park Road and the entrance to the Ramada Hotel. Temporary Suspension of On-Street Waiting/Loading – Solihull Town Centre Service Road south side (4 out of 8 bays) opposite 40-52 Station Road; Drury Lane eastern side all bays directly fronting 14- 26 Drury Lane; and Mill Lane eastern side all bays fronting 38 - 44 Mill Lane. Temporary Maximum 20mph Speed Limits – Knowle and Meriden Village Centres A4141 Warwick Road/High Street – from a point approximately 52m north west of Lodge Road, running in a south easterly then southerly direction for a distance of approximately 600m to a point adjacent to 1706 Warwick Road, Knowle; B4101 Wilsons Road – from A4141 High Street to B4101 Kenilworth Road; Kenilworth Road – from A4141 High Street to a point approximately 20m east of B4101 Wilsons Road; B4101 Station Road – from a point approximately 15m east of St Johns Close, running in an easterly direction to A4141 High St/Warwick Rd; Lodge Road – from Dell Farm Close to A4141 Warwick Road/High Street); B4104 Birmingham Road/Main Road – from a point approximately 30m west of its junction with B4102 Hampton Lane, running in a south easterly direction for a distance of approximately 255m to a point 40m north west of its junction with Strawberry Fields, Meriden; and B4102 Hampton Lane/Fillongley Road – from a point adjacent to the property known as Corner Cottage, running in a north easterly direction for 145m to a point 10m west of its junction with Winspear Close. None of the restrictions shall apply to Fire and Rescue, Ambulance, Police, Military or Special Forces purposes when responding to emergencies. The Metropolitan Borough of Solihull (Various Roads, Solihull) (Carriageway Resurfacing Road Closures) Temporary Traffic Regulation Order 2020

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety: Date(s) and times when restriction will apply: for a maximum of ten days or nights between the period Sunday 6 September to Tuesday 29 September 2020. **Cornyx Lane, Solihull** – from Alston Road to Damson Lane – 9am to 3:30pm only. Alternative routes via Alston Road, Damson Lane and Cornyx Lane. Vice versa for the opposite direction. **Berry Hall Lane, Bickenhill** – from Ravenshaw Lane to Henwood Lane – 8am to 5pm only. Alternative routes via Hampton Lane, Ravenshaw Lane and Henwood Lane. Vice versa for the opposite direction. **Hurdis Road, Shirley** – from outside number 76 Hurdis Road to Bills Lane – 8am to 5pm only. Alternative routes via Bills Lane, Shirley Park Road and Grenville Road. Vice versa for the opposite direction. **Tanners Lane, Meriden** – from the roundabout with Spencers Lane to just before the junction with Nailcote Avenue – 9am to 3:30pm only. Alternative routes via Tanners Lane, Station Avenue, Duggins Lane and Spencers Lane. Vice versa for the opposite direction. **Prospect Lane, Solihull** – from the roundabout with Streetsbrook Road to junction with Ralph Road – 9:30am to 3:30pm, only. Alternative routes via Streetsbrook Road, Sharmans Cross Road and Prospect Lane. Vice versa for the opposite direction. **Chester Road, Castle Bromwich** – from the roundabout with Hall Lane, northwards for a distance of approximately 340m to a point adjacent to the carpark entrance of Castle Bromwich Hall Gardens. – 8am to 5pm only. Alternative routes for traffic will not be signed due to the cul-de-sac nature of the route. **A45 Coventry Road** – closure of the junction 6 slip road, West (Birmingham) bound side only. – 9pm - 5am only. Alternative routes for traffic will be signed in an Easterly (Coventry) bound direction via A45 Coventry Road to the Stonebridge Roundabout at its junction with the A452 Kenilworth Road and then back in a Westerly (Birmingham) bound direction. Access will be maintained through the site for Police, Fire and Ambulance Services responding to emergencies. Pedestrian and vehicle access to all properties within the restriction will be maintained along defined routes throughout the period of closure.
