**(Damson Parkway) (Temporary 30mph Speed Limit)
Order 2020**

The Council gives notice that it intends to extend the duration of above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow the construction of a new Jaguar Land Rover Logistics Operations Centre to be undertaken in safety. Temporary Speed Limit (from 40mph down to 30mph) for the following locations and times with diversion routes: Damson Parkway – from outside of Jaguar Land Rover Gate D1, past the junction with Old Damson Lane to the junction of the A45 Coventry Road will continue in force from 8th December 2020 to 31st March 2021. **(Cuttle Pool Lane, Temple Balsall) (Road Closure)
(Temporary Traffic Regulation) Order 2020**
