

**ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)  
THE M42 AND M40 MOTORWAYS  
(M42 JUNCTION 3A) (LINK ROADS)  
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2020**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the M42 and M40 Motorways, in the County of Warwickshire, to enable survey work to be carried out.

The effect of the Order will be to close, at different times, the link road leading –

- (1) from the eastbound carriageway of the M42 to the northbound carriageway of the M42, at Junction 3a;
- (2) from the southbound carriageway of the M42 at Junction 3a, to the southbound carriageway of the M40;
- (3) from the southbound carriageway of the M42 to the westbound carriageway of the M42 at Junction 3a; and
- (4) to the northbound carriageway of the M42 at Junction 3a, from the northbound carriageway of the M40.

The work will be carried out in phases overnight between –  
21:00 hours and 06:00 hours on Monday to Thursday;  
22:00 hours on Friday and 07:00 hours on Saturday;  
21:00 hours on Saturday and 07:00 hours on Sunday; and  
21:00 hours on Sunday and 06:00 hours on Monday.

The work is expected to start on Tuesday 5 January 2021 and continue for approximately eight weeks. The Order will come into force on 4 January 2021.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures.

Diversion routes via the A3400 and alternative junctions of the M42 and the M40 will be signed.

THE A452 TRUNK ROAD (SOLIHULL) (TEMPORARY  
PROHIBITION OF TRAFFIC IN LAYBY) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the A452 Trunk Road, in the Metropolitan Borough of Solihull, to enable street lighting sign installation works to be carried out.

The effect of the Order will be to close the layby adjacent to the northbound carriageway of the A452 Chester Road approximately 120 metres northwest of the roundabout junction of the A452 with the A45 slip roads, known as Stonebridge Roundabout.

**The work will be carried out overnight between 22:00 hours and 06:00 hours and is expected to start on Wednesday 6 January 2021.** The Order will come into force on 4 January 2021.

Vehicles being used for police, fire and rescue authority or ambulance purposes and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closure.
