

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

FORSHAW HEATH LANE & FORSHAW HEATH ROAD, TANWORTH IN ARDEN

Order Effect: Roads closed to vehicular traffic in two phases as follows:

Forshaw Heath Lane closed from a point outside Forshaw Lodge/Old School House to the M42 bridge.

Forshaw Heath Road closed between its junctions with Forshaw Heath Lane and Poolhead Road, to vehicular traffic.

Reason for Order: To enable works for the renewal of a water main.

Order Commences: 4 January 2021 for up to 18 months.

Anticipated Completion:

Phase 1 – 4 January -15 January 2021.

Phase 2 – 18 January -12 March 2021.

Access & Diversion:

1. Forshaw Heath Lane, Alcester Road, Penn Lane, A435 M42 J3 Roundabout, Forshaw Heath Road.

2. Poolhead Lane, Mill Lane, Tanners Green Lane, Alcester Road, A435 M42 J3 Roundabout, Forshaw Heath Road.

LAPWORTH STREET, LAPWORTH

Order Effect: Road closed to vehicular traffic from a point near to Chestnut House for a distance of approximately 500 metres.

Reason for Order: To enable underground cabling works for a new connection, 09.30hrs-15.30hrs.

Order Commences: 6 January 2021 for up to 18 months.

Anticipated Completion: 8 January 2021.

Access & Diversion: Lapworth Street, Mill Lane, Finwood Road, Old Warwick Road and vice versa.

Order Effect: Road closed to vehicular traffic from Last House before the canal bridge south to the junction with Old Warwick Road.

Reason for Order: To safely enable Openreach works in underground structure.

Anticipated Completion: In one day on 5 January 2021.

Access & Diversion: Mill Lane, Rising Lane, Packwood Lane, Old Warwick Road and vice versa.

PUBLIC FOOTPATHS SD278 IN THE PARISH OF TANWORTH-IN-ARDEN

Order Effect: Footpath closed to all traffic from the intersection point of path SD278 & SD278b north of the railway (O/S ref. SP 09843 74020) to the intersection point of path SD278 & SD276b south of the railway (O/S ref. SP 09233 73691).

Reason for Order: To avoid the likelihood of danger to the public while works are being carried out on or near to the footpath

Order Commences: 4 January 2021 for up to 6 months.

Access & Diversion: A-B Path SD276b B-C Forshaw Heath Rd/Rumbush Lane C-D Path SD278 D-E Path SD278.

Order Effect: Road closed to vehicular traffic between its junctions with Chapel Lane and Packwood Road.

Anticipated Completion: 22 January 2021.

Access & Diversion: Cheshetts Wood Road, Packwood Road, Vicarage Road, Packwood Lane, Rising Lane and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
