The council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety along Damson Parkway – from the A45 junction traffic lights to the island at the junction of Damson Lane with Damson Parkway (outside of Jaguar Land Rover entrance) between Monday 22nd February 2021 until Friday 7th March 2021 from 2200hrs to 0600hrs each night.
