## (Neville Road, Shirley) (Restriction of Waiting) Order 2020

The Council has made this Order under the Road Traffic Regulation Act 1984 as amended, the Traffic Management Act 2004 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Solihull) Order 2007, where applicable, and all other enabling powers. Anyone wishing to question the validity or provisions of the Order should apply to the High Court within six weeks from the date that the Order became effective. The Order, which comes into force on 11 March 2021, will introduce the following: Restriction of Waiting - Monday to Friday - 0900 to 1100hrs and 1400 to 1500hrs Neville Road (west side) - from a point approx. 15m south of Sansome Road, southwards for approx. 74m. Neville Road (east side) - from a point approx. 15m south of Sansome Road, southwards for approx. 77m. Neville Road (north-west side) - from a point approx. 16m south of Binton Road, south-westwards for approx. 46m. Neville Road (south-east side) - from a point approx. 28m south of Binton Road, south-westwards for approx. 39m. Neville Road (south-east side) - from a point approx. 45m south of Lindridge Road, south-westwards then southwards for approx. 147m. Neville Road (west side) – from a point approx. 24m north of Hawkesbury Road, southwards for approx. 40m. Hawkesbury Road (north-east side) - from Neville Road eastwards for approx. 15m; and Hawkesbury Road (south-west

side) - from Neville Road eastwards for approx. 23m.

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety along Damson Parkway - from the A45 junction traffic lights to the island at the junction of Damson Lane with Damson Parkway (outside of Jaguar Land Rover entrance) between Monday 15th March 2021 until Friday 28th March 2021 from 2200hrs to 0600hrs each night. Reason for restriction: Construction of new road realignment of Damson Parkway to allow for construction of Jaguar Landrover LOC development. Diversion route: Signed via Damson Parkway (B4105), Solihull Bypass (A41), Hampton Lane (B4102), Catherine De Barnes Lane (B4438), Coventry Road (A45) and Vice versa for the opposite direction. Access cannot be provided through the restriction for Police, Fire and Ambulance Services responding to emergencies. ## (Guernsey Drive, Smith's Wood) (Footpath Closure) Temporary Traffic Regulation Order 2021
