The Metropolitan Borough of Solihull (Bills Lane, Shirley) (Footway Closure) Temporary Traffic Regulation Order 2021

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all pedestrian traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety: Location: Leading from Bills Lane to Mallaby Close – a length of approx. 60m. Date(s) and time(s) when restriction will apply: from Thursday 3rd June 2021 at 08:00hrs until Wednesday 16th June 2021 at 16:00hrs. Reason for restriction: New service connection. Works on behalf of: Western Power Distribution. Diversion route: Signed via Bills Lane, Langcomb Road and Mallaby Close. Vice versa for the opposite direction. Access will be maintained through the site for Police, Fire and Ambulance Services responding to emergencies.
