Works include the formation of a specific DDA parking bay, an ramp for clear and level access and a porch to the front elevation match the neighbouring properties. The porch and ramp result in the loss of parking space however, this is to be reinstated with the removal of the redundant garden store. The porch is being proposed in order to create a demarked sanitisation and sheltered administration area. Other works include the replacement of a side window with a doorway along with other window works to the rear in order to provide enhanced ventilation and a defined one way system across the ground floor.

**The Metropolitan Borough of Solihull (Dorridge Village) (Total Prohibition of Waiting,  
Restriction of Waiting and Restricted Parking Zone) Order 2021**

The Council proposes to make this Order under the Road Traffic Regulation Act 1984 as amended, and all other enabling powers. The proposals will introduce various waiting restrictions to discourage obstructive all day parking by commuters using Dorridge Station, regulate parking at drop off and pick up times for Dorridge Infant and Junior School and also aim to reduce the impact of any displaced parking; improving the amenities of the area and helping to aid the free passage of traffic along lengths of the following roads: Beckford Croft, Beconsfield Close, Blue Lake Road, Bushwood Drive, Cawdon Grove, Clyde Road, Copstone Drive, Dorridge Road, Earlswood Road, Edstone Close, Ernsford Close, Fennis Close, Foxbury Drive, Gladstone Road, Grange Road, Granville Road, Grove Road, Hanbury Road, Hansell Drive, Harrington Close, Hartlebury Close, Hinchwick Court, Kingscote Road, Knowle Wood Road, Longford Close, Manor Road, Middlefield Avenue, Paddock Drive, Poplar Road, Rodborough Road, Swinford Grove, Walcot Green, Warren Drive, Westfield Close, Woodchester Road, Woodstock Crescent. The proposal aims to regulate on-street parking, help to facilitate the free passage of traffic, aid visibility and discourage obstructive parking. **(Birchy Leasowes Lane, Dickens Heath) (Road Closure) Temporary Traffic Regulation

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety along Birchy Leasowes Lane – full length from Dickens Heath Road to Tile House Lane from Thursday 15th July 2021 at 07:30hrs until Saturday 28th August 2021 at 18:30hrs for gas mains replacement works. **(A34 Stratford Road, Shirley) (Central Reservation Gap Closure) (Experimental)  
Order 2021**

Notice is hereby given that the Council have made the above mentioned Experimental Order under the provisions of Sections 9 and 10 of the Road Traffic Regulation Act 1984 as amended, and all other enabling powers. The Order shall come into effect on **19 July 2021** and will remain in force on an experimental basis for a maximum period of up to 18 months.
