The Metropolitan Borough of Solihull (Birchy Leasowes Lane, Dickens Heath) (Road Closure) Temporary Traffic Regulation Order 2021

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety along Birchy Leasowes Lane – full length from Dickens Heath Road to Tile House Lane from Thursday 15th July 2021 at 07:30hrs until Saturday 28th August 2021 at 18:30hrs for gas mains replacement works. Diversion route: Signed via Dickens Heath Road and Tilehouse Lane. Vice versa for the opposite direction. Access will be maintained through the site for Police, Fire and Ambulance Services responding to emergencies. Proposed Total Prohibition of Waiting – No Waiting at Any Time Skelcher Road (west side) – from a point approx. 12 metres from its junction with Newborough Road northwards for approx. 32 metres. **Skelcher Road (east side)** – from a point approx. 12 metres from its junction with Newborough Road northwards for approx. 3 metres. **Proposed Revocation of existing Loading Only Bay Newborough Road (south side)** – from a point approx. 145 metres west from its junction with Haslucks Green Road westwards for approx. 8 metres.
