

(Chester Road, Kingshurst) (Road Closure) Temporary Traffic Regulation Order 2021

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following telecoms works can be undertaken in safety along Service Road adjacent Chester Road, Kingshurst, B36 0JU – from its junction with Buckingham Road to property number 489 Chester Road from Thursday 5th August 2021 to Friday 20th August 2021.
