

ROAD TRAFFIC REGULATION ACT 1984 SECTIONS 14(1)(a), 14(7) AND 15(2) THE M42 AND M6 MOTORWAYS (M42 JUNCTION 5 TO JUNCTION 7) (TEMPORARY RESTRICTION AND PROHIBITION OF TRAFFIC) ORDER 2022

NOTICE IS HEREBY GIVEN that National Highways Limited (Company No. 9346363) intends to make an Order on the M42 Motorway, in the Metropolitan Borough Solihull and in the County of Warwicksh to enable junction improvement and kshire. maintenance works to be carried out.

- The effect of the Order, will be to, at different times, –

described in (2) (a) and (b) above. The work is expected to start on Tuesday 1 February 2022 and continue for approximately forty-two months. The closures will be carried out mainly overnight between 21:30 hours and 05:30 hours with some full weekend closures from 21:30 hours on Friday to 05:30 hours on Monday. The speed restriction and emergency refuge area closures will be in operation from 21:30 hours on Tuesday 1 February 2022 for 24 hours per day for the duration of the works. The Order will come into force on 25 January 2022. Vehicles being used for police, fire and Vehicles being used for police, fire and rescue authority or ambulance purposes w be exempt from the speed restrictions and will closures.
