Temporary Traffic Regulation Order 2022

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following resurfacing works can be undertaken in safety along Blossomfield Road, Solihull – from its junction with Danford Lane to its junction with Streetsbrook Road for 11 nights (20:00hrs to 06:00hrs) from Monday 21st March 2022 until Thursday 31st March 2022. Diversion route: Signed via Danford Lane, Sharmans Cross Road, and Streetsbrook Road. Vice versa for the opposite direction. Access **cannot** be provided through the restriction for Police, Fire and Ambulance Services responding to emergencies. Pedestrian access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of closure.
