**The Metropolitan Borough of Solihull
(Dorridge Fun Run) (Road Closures and Total Prohibition of Waiting) Temporary Traffic Regulation Order 2022**

The Council gives notice that it has made the above Order in accordance with the Road Traffic Regulation Act 1984 as amended by the Road Traffic Regulation (Special Events) Act 1994 and being satisfied that the traffic on the roads listed below should be restricted or prohibited in the interests of public safety to Dorridge Fun Run participants: Temporary Road Closures – 07:00hrs until 15:00hrs on Sunday 12th June 2022 along Manor Road, Station Road, Station Approach, Dorridge Road, Blue Lake Road, Darley Green Road, Bakers Lane, Packwood Road, Vicarage Road, Windmill Lane and Grange Road, Dorridge. (Widney Lane, Solihull) (Road Closure) Temporary Traffic Regulation Order 2022
