The Order, which comes into force on 22 December 2022, will introduce the following: **Dorridge Long-Stay Pay and Display Car Park, off Grange Road, Dorridge (rear of Sainsbury's Petrol Filling Station) Operational Tariff Hours** Monday to Friday Only between 00:00hrs and 17:59hrs (including all Public and Bank Holidays). **Parking Tariffs** Daily Tariff – arrival between 00:00hrs and 11:59hrs – £5.00 (parking permitted until 23:59hrs). Daily Tariff – arrival between 12:00hrs and 17:59hrs – £3.50 (parking permitted until 23:59hrs). Evening Tariff – arrival between 18:00hrs and 23:59hrs – Free (no ticket required). **Season Ticket Tariffs** Weekly – £20.00. Monthly – £110.00. Annually – £1040.00. **Permits** As allocated by Solihull MBC. **General Conditions of Use** Unlimited parking for Blue Badge Holders displaying a valid Blue Badge. Cars, motor-cycles and light goods vehicles only. Parking in marked bays only for respective class of vehicle. Methods of payment – cash or digital/electronic alternatives.
