### The Metropolitan Borough of Solihull (Footpath M225 Back Lane, Meriden) (Footpath Closure) Temporary Traffic Regulation Order 2022

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all pedestrian and permitted footpath traffic should be restricted or prohibited to ensure that the following property development works can be undertaken in safety along Footpath M225 – through Barnacle Farm, Back Lane, Meriden from 29 December 2022 for a maximum period of 6 months or until a permanent footpath diversion is implemented, whichever the sooner. ### (Faulkner Road, Solihull) (Road Closure) Temporary Traffic Regulation Order 2022
