### **The Metropolitan Borough of Solihull (A34 Stratford Road, Shirley) (Central Reservation Gap Closure) (Experimental) Order 2021 (Modification No.1) (Making of Permanent Order)**

The Council has now made this Order on a permanent basis under the Road Traffic Regulation Act 1984 as amended, the Traffic Management Act 2004 and all other enabling powers. The reasons for this Order can be obtained by written request from the address below; or by inspecting the documents at Solihull Connect, The Core, Theatre Square, Touchwood, Solihull during normal opening hours or via <https://www.solihull.gov.uk/Roads-pavements-and-streetcare//Traffic-regulation-orders> A copy of the Order is available upon request. Anyone wishing to question the validity or provisions of the Order should apply to the High Court within six weeks from the date that the Order became effective. The Order provisions shall continue in force indefinitely from 19 January 2023, and shall permanently maintain the following:

**Central Reservation Gap Closure** Stratford Road (A34) – Gap in the central reservation at its junction with Stanway Road, approximately 40 metres in length.  
**Prohibition of U-Turn** Stratford Road (A34) – Gap in the central reservation at its junction with Richard Lewis Way. From the southbound carriageway to the northbound carriageway.
