ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

C20 POOLHEAD LANE, FORSHAW HEATH, TANWORTH-IN-ARDEN

Order Effect: Road closed to vehicular traffic between its junctions with Small Lane and Forshaw Heath Road.

Reason for Order: To safely enable carriageway patching and associated works. Road closed 09.30hrs-15.00hrs.

Order Commences: 6 March 2023 for up to 18 months.

Anticipated Completion: 6 March 2023.

Access & Diversion: Forshaw Heath Road, Norton Lane, Valley Road, Earlswood Common, Broad Lane, Poolhead Lane and vice versa. Access/Egress to be maintained where possible to businesses and residents only.

C89 LEAFY LANE (AKA CUT THROAT LANE), EARLSWOOD

Order Effect: Road closed to vehicular traffic between its junctions with Salter Street and Umberslade Road.

Order Commences: 3 March 2023 for up to 18 months.

Anticipated Completion: 3 March 2023.

Access & Diversion: Leafy Lane (Cut Throat Lane), Tithe Barn Lane, Umberslade Road and vice versa.

D5047 SPRING LANE, LAPWORTH

Order Effect: Road closed to vehicular traffic between its junctions with Wharf Lane and Church Lane.

Anticipated Completion: 3 March 2023.

Access & Diversion: Wharf Lane, Old Warwick Road, Church Lane and vice versa. Access/Egress to be maintained where possible to businesses and residents only.

D5048 HOLE HOUSE LANE, LAPWORTH

Order Effect: Road closed to vehicular traffic between its junction with Tapster Lane and Tinkers Lane.

Order Commences: 3 March 2023 for up to 18 months.

Anticipated Completion: 3 March 2023.

Access & Diversion: Tapster Lane, Bushwood Lane, Wheatsheaf Lane, Hole House Lane and vice versa. Access/Egress to be maintained where possible to businesses and residents only.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
