(Castle Lane, Castle Close and Faulkner Road, Solihull)
(Total Prohibition of Waiting) Order 2022**

The Council has made this modified Order under the Road Traffic Regulation Act 1984 as amended, the Traffic Management Act 2004 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Solihull) Order 2007, where applicable, and all other enabling powers. Anyone wishing to question the validity or provisions of the Order should apply to the High Court within six weeks from the date that the Order became effective. The Order, which comes into force on 9 March 2023, will introduce the following: **Total Prohibition of Waiting – No Waiting at Any Time Castle Close (both sides)** – from its junction with Castle Lane, southwards for approx. 15m. **Faulkner Road (east side)** – from its junction with Castle Lane, southwards for approx. 22m. **Faulkner Road (west side)** – from its junction with Castle Lane, southwards for approx. 20m. **Castle Lane (south side)** – from a point approx. 16m east of its junction with Faulkner Road, westwards for approx. 37m. **Castle Lane (south side)** – from a point approx. 16m east of its junction with Castle Close, westwards for approx. 30m.

**(Airport Way Exit Slip Road, Bickenhill) (Road Closure)
Temporary Traffic Regulation Order 2023**
