**The Metropolitan Borough of Solihull (B4102/B4025 Warwick Road, Solihull) (Prohibition of U-Turn Movements) Order 2022**  
The Council has made this Order under the Road Traffic Regulation Act 1984 as amended, and all other enabling powers. The reasons for this Order can be obtained by written request from the address below; or by inspecting the documents at Solihull Connect, Library Square, Touchwood, Solihull during normal opening hours or via <https://www.solihull.gov.uk/Roads-pavements-and-streetcare//Traffic-regulation-orders> A copy of the Order is available upon request. Anyone wishing to question the validity or provisions of the Order should apply to the High Court within six weeks from the date that the Order became effective. The Order, which comes into force on 13 April 2023, will introduce the following: **Prohibition of U-Turn Movements B4102/B4025 Junction of Warwick Road, Solihull** – no vehicle travelling eastbound (towards M42 motorway) shall be permitted to carry out a U-Turn manoeuvre at its junction with the B4102 Hampton Lane to then travel westbound along the B4102 Warwick Road (towards Solihull Town Centre).

### **(Smith's Lane, Bentley Heath) (Road Closure) Temporary Traffic Regulation Order 2023**

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following gas connection works can be undertaken in safety along Smith's Lane, Bentley Heath – for its entire length from its junction with Widney Manor Road to its junction with Browns Lane from Monday 10 April 2023 at 08:00hrs until Friday 21 April 2023 at 17:00hrs. Diversion route: Signed via Widney Manor Road, Widney Road, Tilehouse Green Lane and Browns Lane. Access **cannot** be provided through the restriction for Police, Fire and Ambulance Services responding to emergencies. Pedestrian access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of closure.
