### The Metropolitan Borough of Solihull (Summerfield Road, Solihull) (Road Closure) Temporary Traffic Regulation Order 2024

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that all traffic should be restricted or prohibited to ensure that the following works can be undertaken in safety along Summerfield Road, Solihull – From its junction with Castle Lane to its junction with Kimberley Road from Monday 11th March 2024 at 08:00 until Friday 22nd March 2024 at 17:00hrs. Reason for restriction: Excavation to facilitate repair of sewer pipes. Works on behalf of: Severn Trent Water. Diversion route: Castle Lane, Kimberley Road and Summerfield Road. Vice versa for the opposite direction. Access **will** be maintained through the site for Police, Fire and Ambulance Services responding to emergencies. Pedestrian access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of closure. ### (B4104 Birmingham Road and Showell Lane, Meriden) (40 MPH Maximum Speed Limit) (Revocation) Order 2023

The Council has made this Order under the Road Traffic Regulation Act 1984 as amended, and all other enabling powers. The reasons for this Order can be obtained by written request from the address below; or by inspecting the documents at Solihull Connect, Library Square, Touchwood, Solihull during normal opening hours or via <https://www.solihull.gov.uk/Roads-pavements-and-streetcare//Traffic-regulation-orders> A copy of the Order is available upon request. Anyone wishing to question the validity or provisions of the Order should apply to the High Court within six weeks from the date that the Order became effective. The Order, which comes into force on 8 March 2024, will introduce the following: **Revocation of 40 MPH Maximum Speed Limit (to become 30 MPH) B4104 Birmingham Road** – from a point approx. 24m west of its junction with Bonneville Close, westwards for approx. 1654m. **Showell Lane** – from its junction with Birmingham Road (B4104), northwards for approx. 26m.
