On 15th December 2023, the Secretary of State for the Environment confirmed with modifications the above order made under Section 119, of the Highways Act 1980.

The effect of the order as confirmed

 1) The public right of way number SL20A over land situate at Arden Academy leading from Point A (Grid ref: SP 41794,27634) at the north eastern edge of Arden Academy, Knowle off Milverton Road heading around various school buildings via Point B (Grid ref: SP 41787 27838) then via Point C (Grid ref: SP 41787,27638) then via Point C (Grid ref: SP 41786,27638) along a tarmac path past another school building near Station Road to Point D (Grid ref: SP 41783,27640),
- a short distance off Station Road to. to...
 2) Leading from Point A (Grid ref: SP 41794,27634) at the north eastern edge of Arden Academy, Knowle off Milverton Road and heading in a north westerly direction but close to the northern edge of the school boundary passing various service buildings before joining a new tarmac route at Point E (Grid ref: SP 41792,27636) and proceeding north westerly via a turning point at Point F (Grid or 41/92,27636) and proceeding north westerly via a turning point at Point F (Grid ref: SP 41792,27637) before heading along northern edge of school grounds via Point G (Grid ref: SP 41790,27640) and H (Grid ref: SP 41785,27643) along a new tarmac path before turning in a south westerly of the second s westerly direction parallel with Station Road and re-joining the rest of the existing footpath at Point D (Grid ref: SP 41783,27640).

There shall from the date of confirmation of this order be a public footpath over the land situate at Arden Academy, Knowle, Solihull described in Part 2 of the Schedule and shown by a broken black line on the map contained in the order.

The minor amendment made to the confirmed Order by the Secretary of State has replaced the final line of the order in Part 2 of the Schedule to "The part of this public footpath number (SL120A) is 162 metres in length with a width of 1.8m"
