ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY PROHIBITION OF RIGHT TURNS WATERSIDE, STRATFORD UPON AVON & TEMPORARY ONE WAY TRAFFIC D6234 SHEEP STREET, STRATFORD UPON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order prohibiting all traffic from turning right from Waterside into Sheep Street, Stratford upon Avon and imposing temporary One Way traffic movement in Sheep Street, Stratford upon Avon. These measures are required to safely facilitate critical gas mains replacement.

The Order will commence on 11 January 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 February 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be affected will be maintained at all times.

Vehicles using Sheep Street will be restricted to One Way only movement in an easterly direction towards Waterside.

There will be no right turn from Waterside to Sheep Street for the duration of the works.

An alternative route will be signed and is available via: D6236 Waterside, D6237 Southern Lane, D6244 Old Town, D6231 Church Street and D6232 Chapel Street. The Contractor dealing with this matter is Balfour Beatty (Tel: 0800 121 4444).

THE WARWICKSHIRE COUNTY COUNCIL (A3400 BIRMINGHAM ROAD, BISHOPTON, STRATFORD-ON-AVON) (30MPH & 50MPH SPEED LIMIT) ORDER 2016

Warwickshire County Council propose to make the above Order under the Road Traffic Regulation Act 1984 the effect of which will be to impose a new 30mph & 50mph speed limit on the length of road mentioned in Schedule 1 & 2 below.

SCHEDULE 1

(Revoking – The Warwickshire County Council
(Various Roads, District Of Stratford-On-Avon)
(Restricted Roads) Order 2009)

Schedule, 1, A3400 Birmingham Road, Stratford

From the centre of One Elm Bridge over the Stratford upon Avon Canal, north westwards to a point 195 metres south-east of its junction with the A46 (Warwick to Evesham Road), a distance of approximately 1.58 kilometres.

SCHEDULE 2

(30 mph speed limit by virtue of street lighting)

A3400 Birmingham Road, Stratford

From the centre of One Elm Bridge over the Stratford upon Avon Canal, north westwards to a point 60 metres south of its junction with the A46 (Warwick to Evesham Road).

SCHEDULE 3

(50 mph speed limit)

A3400 Birmingham Road, Stratford

From its junction with the A46 (Warwick to Evesham Road) (give way lines) in a southerly direction for a distance of 60 metres
