

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D5257 KINGTON LANE, CLAVERDON**

Warwickshire County Council has made a Temporary Traffic Order closing D5257 Kington Lane, Claverdon at a point adjacent to the property known as Barn Cottage, to vehicular traffic.

The closure is required to facilitate the installation of electrical cable.

## **TEMPORARY PROHIBITION OF RIGHT TURNS WATERSIDE, STRATFORD UPON AVON & TEMPORARY ONE WAY TRAFFIC D6234 SHEEP STREET, STRATFORD UPON AVON**
