

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D6355 THE BANK, LIGHTHORNE

Warwickshire County Council has made a Temporary Traffic Order closing D6355 The Bank, Lighthorne from the junction of Church Lane to a point outside the property known as Southview, to vehicular traffic.

The closure is required to facilitate works to clear BT duct blockages.
