

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PUBLIC FOOTPATHS AT BEECHAM WALK & GIFFORD WALK, STRATFORD UPON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Public Footpaths at Beecham Walk, Stratford upon Avon & Gifford Walk, (from the junction of Trevelyan Crescent to a point outside numbers 24 & 27) Stratford upon Avon, to all traffic.

The closure is required to safely facilitate major gas works.

The Order will commence on 7 March 2016 and will last for a period of 6 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 29 March 2016.

Access to and egress from properties and land situated adjacent to the length of footpaths to be closed will be maintained where possible.

Alternative routes will be signed and are available:

For Beecham Walk – please use Trevelyan Crescent (and vice versa)

For Gifford Walk – please use the footpath from Drayton Avenue to Bishopton Lane, Whittaker Way (and vice versa).

TEMPORARY CLOSURE OF CYCLE LANE, D6236 WATERSIDE, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing the Cycle Lane on the D6236 Waterside, Stratford upon Avon from the junction of Sheep Street to the junction of Chapel Lane, to all traffic.

TEMPORARY CLOSURE OF D6515 ADMINGTON ROAD, PRESTON ON STOUR

Warwickshire County Council has made a Temporary Traffic Order closing D6515 Admington Road, Preston on Stour at a point outside the property known as The Lodge, to vehicular traffic.

The closure is required for the safety of all road users and of the contractors working in the carriageway facilitating the renewal of a pressure reducing valve in the grass verge.

TEMPORARY CLOSURE OF C100 WINDMILL HILL, TEMPLE GRAFTON

TEMPORARY CLOSURE OF D5256 LANGLEY ROAD, CLAVERDON

THE WARWICKSHIRE COUNTY COUNCIL (B4035 CAMPDEN ROAD, SHIPSTON ON STOUR) (40MPH & 50MPH SPEED LIMIT) ORDER 2016

Warwickshire County Council propose to make the above Order under the Road Traffic Regulation Act 1984 the effect of which will be to impose a 40 mph and 50mph speed limit on the length of road mentioned in the Schedule below. SCHEDULE 1 (40 mph speed limit)

B4035 Campden Road, Shipston on Stour

That length of B4035 Campden Road which extends from a point 73 metres west of its junction with Sadlers Avenue to a point 500 metres south west of the property boundary between Mount Farm and Mount Farm Cottage.

SCHEDULE 2 (50 mph speed limit)

B4035 Campden Road, Shipston on Stour

That length of B4035 Campden Road which extends from a point 500 metres south west of the property boundary between Mount Farm and Mount Farm Cottage in a generally south westerly direction to a point 20 metres east of its junction with A429 Fosse Way.

TEMPORARY 10 MPH SPEED LIMIT – A429 WARWICK ROAD, WELLESBOURNE

Warwickshire County Council has made a Temporary Traffic Order the effect of which will be to impose a temporary speed limit of 10 mph on the above named road, between The Horticultural Centre and to the nearest roundabout.

The temporary speed limit is required for the safety of all road users and of the Contractors working on the carriageway.

The Order will commence on 23 February 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 24 February 2016.
