

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PUBLIC FOOTPATH FROM CROMPTON AVENUE TO TOWER HILL, BIDFORD ON AVON

Warwickshire County Council has made a Temporary Traffic Order closing the Public Footpath from Crompton Avenue to Tower Hill, Bidford on Avon to all traffic.

The closure is required to safely facilitate a gas mains replacement.

The Order will commence on 29 February 2016 and will last for a period of 6 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 11 March 2016.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained where possible.

An alternative route will be signed and is available via: Crompton Avenue, Waterloo Road, Tower Hill (and vice versa).
