## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

### TEMPORARY CLOSURE OF NEW INN LANE, ABBOTTS SALFORD, SALFORD PRIORS

Warwickshire County Council has made a Temporary Traffic Order closing New Inn Lane, Abbots Salford, Salford Priors, from the junction with Salford Road to a point outside the property known as Wychcroft, to vehicular traffic.

The closure is required to facilitate works for the construction of a new vacuum sewer and chambers.

The Order will commence on 7 December 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 December 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: New Inn Lane, Evesham Road, School Road, Salford Road (and vice versa).

### TEMPORARY CLOSURE OF C72 LOXLEY ROAD, WELLESBOURNE

Warwickshire County Council has made a Temporary Traffic Order closing C72 Loxley Road, Wellesbourne between (but not including) the island with A429 Wellesbourne Bypass to the layby, a distance of approximately 60 metres, to vehicular traffic.

The closure is required for carriageway resurfacing.

The Order will commence on 3 December 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 12 December 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Loxley Road, Loxley Lane, Stratford Road, Wellesbourne Bypass, Dove House Drive and vice versa.

### TEMPORARY CLOSURE OF C116 TANKARDS HILL, STRETTON ON FOSSE

Warwickshire County Council has made a Temporary Traffic Order closing C116 Tankards Hill, Stretton on Fosse, between the junction with Stretton Close and the junction with Harolds Orchard, to vehicular traffic.

The closure is required for carriageway resurfacing.

The Order will commence on 7 December 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 9 December 2016.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: The Green, Church Lane, Main Street, Fosse Way, Campden Road, Stretton Close and vice versa.
