

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF SHOTTERY ROAD, SHOTTERY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Shottery Road, Shottery from the junction with Bell Lane to the junction with Hathaway Lane, to vehicular traffic.

The closure is required because there is insufficient room for vehicles to safely pass whilst works are being executed on or near to the carriageway.

The Order will commence on 16 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 19 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

Please note: The works is being carried out in daytime only allowing the road to be open during the evening and overnight.

An alternative route will be signed and is available via: Hathaway Lane, Evesham Road, Bordon Place, Brookvale Road, Shottery Road, Shottery (and vice versa).

TEMPORARY CLOSURE OF ILMINGTON ROAD, BLACKWELL

Warwickshire County Council has made a Temporary Traffic Order closing Ilmington Road, Blackwell, from Treddington Road heading west for a distance of approximately 50 metres, to vehicular traffic.

The closure is required to facilitate works for the installation of a HV utility cable.

The Order will commence on 4 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Treddington Road, Shipston Road, Blackwell Road, Fosse Way, Darlingscott Road (and vice versa).

TEMPORARY CLOSURE OF HEATH END LANE, SNITTERFIELD

Warwickshire County Council has made a Temporary Traffic Order closing Heath End Lane, Snitterfield, from the junction with the A46 to the junction with Snitterfield Lane, to vehicular traffic.

The closure is required for carriageway patching works.

The Order will commence on 9 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 9 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Snitterfield Lane, Park Lane, A46 and vice versa.

TEMPORARY CLOSURE OF WESTON ROAD, WESTON ON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Weston Road, Weston on Avon, at a point adjacent to the property known as Ardencote, to vehicular traffic.

The closure is required to facilitate works for the connection of new mains water supplies.

The Order will commence on 20 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 22 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF WHITE PUMP LANE, HENLEY IN ARDEN

Warwickshire County Council has made a Temporary Traffic Order closing White Pump Lane, Henley in Arden, from a point approximately 58 metres north west from Deans Green on to White Pump Lane, to vehicular traffic.

The closure is required to facilitate works for the installation of a boundary box.

The Order will commence on 8 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Ramshill Lane, Moat Farm Lane, Chapel Lane, Deans Green Road (and vice versa).

TEMPORARY CLOSURE OF BRIDGE STREET, HAMPTON LUCY
