

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF HATTON BANK LANE, HAMPTON LUCY**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Hatton Bank Lane, Hampton Lucy to vehicular traffic.

The closure is required to facilitate works for the connection of a new gas supply.

The Order will commence on 27 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 31 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Warwick Road, Stratford Road, Hatton Bank Lane (and vice versa).

## **TEMPORARY CLOSURE OF HIGH STREET, SHIPSTON ON STOUR**

## **TEMPORARY CLOSURE OF LONGDON ROAD, DARLINGSCOTE**
