

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF SCHOLARS LANE, STRATFORD UPON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Scholars Lane, Stratford upon Avon, from the junction with Church Street to the junction with Rother Street, to vehicular traffic.

The closure is required to facilitate drainage repair works.

The Order will commence on 5 April 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 18 April 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Church Street, Chestnut Walk, Rother Street and vice versa.

TEMPORARY CLOSURE OF SHOTTERY ROAD, SHOTTERY

Warwickshire County Council has made a Temporary Traffic Order closing Shottery Road, Shottery from the junction with Bell Lane to the junction with Hathaway Lane, to vehicular traffic.

The closure is required because there is insufficient room for vehicles to safely pass whilst works are being executed on or near to the carriageway.

The Order will commence on 16 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 19 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

Please note: The works is being carried out in daytime only allowing the road to be open during the evening and overnight.

An alternative route will be signed and is available via: Hathaway Lane, Evesham Road, Bordon Place, Brookvale Road, Shottery Road, Shottery (and vice versa).

TEMPORARY CLOSURE OF STRATFORD ROAD, HAMPTON LUCY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Stratford Road, Hampton Lucy, from a point approximately 719 metres east of the junction to Hatton Bank Lane to a point approximately 90 metres west of the junction with Church Street, to vehicular traffic.

The closure is required to safely facilitate small mains renewal works in the verge.

The Order will commence on 5 April 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 7 April 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Stratford Road, Hatton Bank Lane, Snitterfield Road, Snitterfield Street, Bridge Street, Vine Cottages, Church Street (and vice versa).

TEMPORARY CLOSURE OF WESTON ROAD, WESTON ON AVON

Warwickshire County Council has made a Temporary Traffic Order closing Weston Road, Weston on Avon, at a point adjacent to the property known as Ardencote, to vehicular traffic.

The closure is required to facilitate works for the connection of new mains water supplies.

The Order will commence on 20 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 22 March 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
