

## ROAD TRAFFIC REGULATION ACT 1984, SECTIONS 14 AND 15 TEMPORARY CLOSURE OF HENLEY STREET, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing Henley Street Stratford upon Avon at its northern end from a point 19 metres south-east of its junction with the kerb-line of the east side of Windsor Street to its junction with Meer Street, to all vehicular traffic, continuing the closure by notice which is currently in place. The closure is required to avoid the likelihood of danger to the public or of preventing or reducing the possibility of danger.

The Order will commence on 7 July 2017 and will expire on 25 November 2018, unless revoked earlier by an Experimental Traffic Order. (Warwickshire County Council does intend to make an Experimental Traffic Order in due course).

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times.

Exemptions will apply to allow access to the police, fire brigade, ambulances, statutory undertakers and for Warwickshire County Council's essential works.

## TEMPORARY 10 MPH SPEED LIMIT – WELLESBOURNE ROAD, BARFORD

Warwickshire County Council proposes to make a Temporary Traffic Order the effect of which will be to impose a temporary speed limit of 10 mph on the above named road. .

The temporary speed limit is required for the safety of all road users and of the contractors working on the carriageway. The Order will commence on 28 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 29 July 2017.

## TEMPORARY CLOSURE OF PUBLIC FOOTPATH SAXONFIELDS, BIDFORD ON AVON

The closure is required to safely facilitate works for the installation of a boundary box.

## TEMPORARY CLOSURE OF PENNYFORD LANE, WOOTTON WAWEN

Warwickshire County Council proposes to make a Temporary Traffic Order closing Pennyford Lane, Wootton Wawen from the junction of Stratford Road and for a distance of approximately 350 metres in a southerly direction, to vehicular traffic.

The closure is required to safely facilitate overhead BT works.

The Order will commence on 28 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 28 July 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Pennyford Lane, Alcester Road, Wootton Rise, Stratford Road (and vice versa).

## TEMPORARY CLOSURE OF D6209 CHURCH LANE, SHOTTERY

## TEMPORARY CLOSURE OF ARMSCOTE ROAD, NEWBOLD ON STOUR

Warwickshire County Council has made a Temporary Traffic Order closing Armscote Road, Newbold on Stour from a point adjacent to Allotment Gardens and for a distance of approximately 50 metres, to vehicular traffic.

The closure is required to facilitate works for the installation of new water connections.

The Order will commence on 10 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 28 July 2017.

## TEMPORARY CLOSURE OF CLOPTON ROAD, STRATFORD UPON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Clopton Road, Stratford upon Avon, from its junction with Birmingham Road to Clopton Court (one lane only), to vehicular traffic.

The closure is required to safely facilitate footpath crossover works.

The Order will commence on 24 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 4 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

The speed restriction is needed for the safety of all road users and of the contractors working in the carriageway for surface dressing preparation; the closure is required to facilitate surface dressing works.

The Speed Restriction Order will commence on 27 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.

The Closure Order will commence 5 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.
