

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF MAYO ROAD, SHIPSTON ON STOUR**

Warwickshire County Council has made a Temporary Traffic Order closing Mayo Road, Shipston on Stour from a point outside property number 26, to vehicular traffic. The closure is required to facilitate a small mains repair.

The Order will commence on 18 July 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 20 July 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Mayo Road, Station Road, Watery Lane, Stratford Road, Badgers Crescent, Donnington Road (and vice versa).

## **TEMPORARY CLOSURE OF B4455 FOSSE WAY, PILLERTON HERSEY**

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4455 Fosse Way, Pillerton Hersey from Bowshot Islands to Ettington Crossroads, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 1 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed on or before 2 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## **TEMPORARY CLOSURE OF D6568 DARLINGSCOTTE ROAD, STRETTON ON FOSSE**

## **TEMPORARY CLOSURE OF CHESTNUT WALK, STRATFORD UPON AVON**

## **NOTICE OF CONFIRMATION OF AN ORDER HIGHWAYS ACT 1980 (PART OF PUBLIC FOOTPATH SD29A CLIFFORD CHAMBERS AND MILCOTE) PUBLIC PATH DIVERSION ORDER 2016**

On 19 June 2017, the Secretary of State confirmed the above Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to DIVERT that section of Public Footpath SD29a commencing at Point A (grid ref 41866 25322) passing under the Stratford Greenway and running generally south west for approximately 715 metres to Point B (grid ref 41806 25298) as shown on the Order Plan. TO A LINE following a metalled path from Point A (grid ref 41866 25322) north north west to Point C (grid ref 41868 25324), then south west along the Stratford Greenway to Point D (grid ref 41810 25298), then west to Point B (grid ref 41806 25298) as shown on the Order Plan, a total distance of approximately 705 metres. The new route shall have a width of 1.4 metres between Points A-C, 2 metres between Points C-D and 1.2 metres between Points D-B.

The Order came into force on 21 June 2017, when Warwickshire County Council issued a certificate of completion, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that any requirement of the Act, as amended, or if any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 13/07/2017 make an application to the High Court.
