

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF TELEGRAPH STREET, SHIPSTON ON STOUR

Warwickshire County Council has made a Temporary Traffic Order closing Telegraph Street, Shipston on Stour, from the junction of Church Street to a point outside Rotherwick Court, to vehicular traffic.

The closure is required to safely facilitate works for the replacement of a broken manhole.

The Order will commence on 22 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 22 August 2017.
