## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D6219 BROOKVALE ROAD & D6225 ORCHARD WAY, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing D6219 Brookvale Road & D6225 Orchard Way, Stratford upon Avon to vehicular traffic.

The closure is required to facilitate carriageway resurfacing works.

The Order will commence on 30 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 3 November 2017. Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Evesham Road, Shottery Road and vice versa.

### TEMPORARY CLOSURE OF IDLICOTE ROAD, HALFORD

Warwickshire County Council proposes to make a Temporary Traffic Order closing Idlicote Road, Halford from Feldon Edge to Halford Lodge, to vehicular traffic.

### TEMPORARY CLOSURE OF A422 BANBURY ROAD, ALVESTON HILL, FELDON WAY, MILESTONE ROAD, WATERLOO DRIVE, DALE AVENUE, JUPITER ROAD, RUSHBROOK ROAD AND MANOR ROAD STRATFORD UPON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing A422 Banbury Road, Stratford upon Avon from Alveston Manor roundabout to the A4390 Trinity Way roundabout to vehicular traffic.

Please Note: the following roads will be closed at their junctions with the A422 Banbury Road: Alveston Hill, Feldon Way, Milestone Road, Waterloo Drive Dale Avenue, Jupiter Road, Rushbrook Road and Manor Road.

The closures are required to facilitate carriageway resurfacing works.

### HIGHWAYS ACT 1980 (PART OF FOOTPATH SS167 WHATCOTE) PUBLIC PATH EXTINGUISHMENT ORDER 2017

The above Order, made on 24 October 2017 under Section 118 of the Highways Act 1980, will **EXTINGUISH** the full length and width of Footpath SS167 from its junction with Footpath SS167a at Point A (grid reference 42965 24466) running generally east for approximately 180 metres to the property boundary of Denwyn at Point B (grid reference 42983 24464) as shown on the Order Plan.

Warwickshire County Council hereby gives notice of its intention to install traffic signals at the junction of Banbury Road with Tiddington Road, Bridge Foot and Swan's Nest, with a pedestrian crossing facility across Tiddington Road, in Stratford upon Avon.
