

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C22 NEW ROAD, LOWSONFORD

Warwickshire County Council proposes to make a Temporary Traffic Order closing C22 New Road, Lowsonford from the junction with Mill Lane to the junction with Preston Road, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 20 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 22 November 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Mill Lane, Finwood Road, Old Warwick Road, Shrewley Common, Back Lane, Narrow Lane, New Road and vice versa.

TEMPORARY CLOSURE OF TREDINGTON ROAD, BLACKWELL, SHIPSTON ON STOUR

TEMPORARY CLOSURE OF D6236 WATERSIDE, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing D6236 Waterside, Stratford upon Avon between Bridge Street and Chapel Lane, to vehicular traffic.

The closure is required to facilitate essential drain maintenance and a trial deployment of flood barrier.
