

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF GOSPEL OAK LANE, PATHLOW

Warwickshire County Council proposes to make a Temporary Traffic Order closing Gospel Oak Lane, Pathlow from a point approximately 692 metres east of Hawkswood Farm, to vehicular traffic.

The closure is required to facilitate a disconnection repair on abandoned asset. The Order will commence on 6 December 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 8 December 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
