

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF MILCOTE ROAD, CLIFFORD CHAMBERS

Warwickshire County Council has made a Temporary Traffic Order closing Milcote Road, Clifford Chambers from a point opposite Rectory Farm to vehicular traffic. The closure is required to facilitate the laying of ducting & the building of a chamber. The Order will commence on 27 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 29 November 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Milcote Road, Clifford Road, Campden Road, Preston Fields Lane (and vice versa).

TEMPORARY CLOSURE OF STATION ROAD, LONG MARSTON

TEMPORARY CLOSURE OF WHEELBARROW LANE, CLAVERDON
