

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF WHEELBARROW LANE, CLAVERDON

Warwickshire County Council has made a Temporary Traffic Order closing Wheelbarrow Lane, Claverdon from the junction with Station Road to the junction with Star Lane, to vehicular traffic.

The closure is required to safely facilitate tree works around overhead power lines. The Order will commence on 13 December 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 December 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Wheelbarrow Lane, Station Road, Star Lane (and vice versa).

TEMPORARY CLOSURE OF VICARAGE LANE, LONG COMPTON, SHIPSTON ON STOUR

- The Warwickshire County Council (Borough Of Rugby) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) Order 2017
