## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF ST PETERS ROAD, KINETON**

Warwickshire County Council has made a Temporary Traffic Order closing St Peters Road, Kineton, from a point outside property number 1 to a point outside property number 13, to vehicular traffic.

The closure is required to facilitate works for the replacement of a broken manhole.

The Order will commence on 15 December 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 15 December 2017, weather permitting.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## **TEMPORARY CLOSURE OF PERCY STREET, STRATFORD UPON AVON**

Warwickshire County Council has made a Temporary Traffic Order closing Percy Street, Stratford upon Avon from a point outside property number 28 to a point outside property number 32, a distance of approximately 30 metres, to vehicular traffic.

The closure is required to facilitate works for the installation of water pipes in the carriageway and footway.

The Order will commence on 15 December 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 15 January 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## **TEMPORARY CLOSURE OF ASCOTT ROAD, WHICHFORD**

Warwickshire County Council has made a Temporary Traffic Order closing Ascott Road, Whichford from a point opposite Coppice View, to vehicular traffic.

The closure is required to facilitate repairs to a water pipe.

The Order will commence on 19 December 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 December 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Ascott Road, Whitchurch Road, Ascott Hill, Whichford Hill, Traitorsford Lane (and vice versa).
