

**WARWICKSHIRE COUNTY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984, SECTION 14
TEMPORARY CLOSURE OF C76 WOOD STREET, STRATFORD UPON AVON**

Warwickshire County Council has made a Temporary Traffic Order closing C76 Wood Street, Stratford upon Avon from High Street to Rother Street, to vehicular traffic. The closure is required to facilitate carriageway patching works. The Order will commence on 19 February 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 20 February 2018. Please note: The works will be carried out between 9.30hrs and 15.30hrs daily. Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: High Street, Chapel Street, Church Street, Chestnut Walk, Rother Street and vice versa. TEMPORARY CLOSURE OF B4632 CLIFFORD ROAD, CLIFFORD CHAMBERS

Warwickshire County Council has made a Temporary Traffic Order closing B4632 Clifford Road, Clifford Chambers from a point 180m north of the river bridge to a point approximately 10m south of the river bridge, to vehicular traffic. The closure is required to facilitate carriageway resurfacing works. The Order will commence on 19 February 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 February 2018, weather permitting. Please note: The works will be carried out over four nights between 20.00hrs and 06.00hrs. TEMPORARY CLOSURE OF BARTON ROAD, WELFORD ON AVON

Warwickshire County Council has made a Temporary Traffic Order closing Barton Road, Welford on Avon to vehicular traffic. The closure is required to facilitate works for the repositioning of the existing bell mouth opening and foul drain. The Order will commence on 17 February 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 25 February 2018. TEMPORARY CLOSURE OF C46 MAIN ROAD/HIGH STREET, BINTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing C46 Main Road/High Street, Binton, from the speed limit signs south of Church Bank to the speed limit signs east of the entrance to the Binton Social Club, to vehicular traffic. The closure is required to facilitate carriageway resurfacing works. The Order will commence on 5 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 12 March 2018. Please note: The roads will be completely closed to traffic from 5 March 2018 until the works are completed. However, the works will be carried out between 09.00hrs and 15.30hrs on weekdays and 08.00hrs and 17.00hrs at the weekend. Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. TEMPORARY 10 MPH SPEED LIMIT – A429 ETTINGTON ROAD, WELLESBOURNE

Warwickshire County Council proposes to make a Temporary Traffic Order the effect of which will be to impose a temporary speed limit of 10 mph on the above named road, from Oakham Cottage in a southerly direction as indicated by traffic signs. The temporary speed limit is required for the safety of all road users and of the contractors resurfacing the carriageway. TEMPORARY CLOSURE OF A3400 WARWICK ROAD/BRIDGEFOOT GYRATORY/A439 WARWICK ROAD, STRATFORD UPON AVON

Warwickshire County Council has made Temporary Traffic Order closing A3400 Bridgefoot Gyratory junctions with A3400 Warwick Road & A439 Warwick Road, Stratford upon Avon, to vehicular traffic. The closure is required to facilitate carriageway resurfacing. The Order will commence on 22 February 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by the morning of 25 February 2018. Please note: It is proposed that the works are carried in stages so that one lane of the road will be passable to traffic at all times and is scheduled as follows:

Warwickshire County Council has made the above named Variation Orders under the Road Traffic Regulation Act 1984, the effect of which is to vary the existing District of Stratford on Avon (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017, as briefly described (by approximate measurements) in the Schedules below. The Orders commence on Monday 19 February 2018. A copy of the Variation Orders, together with a copy of the Order to be varied, plans showing the lengths of road affected and statements of the Council's reasons for making the Variation Orders may be inspected at the Warwickshire County Council Main Reception, Shire Hall, Market Place, Warwick; at Stratford on Avon District Council, Elizabeth House, Church Street, Stratford on Avon; and at the Public Library, Henley Street, Stratford upon Avon during usual opening hours. Any person who desires to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

From a point 10 metres north of its junction with Doctors Lane, northwards for 95 metres – correction of an administrative error which states no return within 2 hours:-

Proposed Bus Stop Clearway between the hours of 9.00am to 6.00pm

STRATFORD COURT, BIRMINGHAM ROAD, STRATFORD UPON AVON

Exclusion of residents of Stratford Court from eligibility for a Zone S2 or Zone S3 parking permit.

TEMPORARY CLOSURE OF D62580 SANDFIELD ROAD & D62530 CHERRY ORCHARD, STRATFORD UPON AVON
