- Warwickshire County Council has made the above Experimental Order under the Road Traffic Regulation Act 1984 ("the 1984 Act"), the effect of which will be to:prohibit motor vehicles from that length of Waterside, Stratford upon Avon which extends between its junctions with Sheep Street and Chapel Lane, at all
- times; and
  2. introduce a one way traffic flow in a westerly
  direction upon that length of Sheep Street, Stratford
  upon Avon which extends from its junction with
  Waterside, westwards for a distance of 115 metres.
  In connection with the Experimental Order, Warwickshire

County Council is proposing to install traffic calming measures as described (by approximate measurements) in the Schedule below.

in the Schedule below. The Experimental Order commences on Monday 29 October 2018 and lasts for a period of up to 18 months. The Experimental Order contains exemptions for the emergency services, statutory undertakers and the RSC. A copy of the Experimental Order, together with plans showing the lengths of road affected, the associated traffic calming proposals and a statement of the Council's reasons for making the Experimental Order, may be inspected at the Main Reception, Shire Hall, Market Place, Warwick and at Stratford on Avon District Council, Elizabeth House, Church Street, Stratford upon Avon and at the Public Library.
