

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PUBLIC FOOTPATH SD161 LANGLEY

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath SD161 Langley, at Grid Reference SP195627, to all traffic.

The closure is required to avoid the likelihood of danger to the public because of the dilapidated and dangerous condition of a bridge along its route.

The Order will commence on 13 November 2018 and will last for a period of 6 months, or until remedial are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained where possible.

TEMPORARY CLOSURE OF MAIN STREET, LONG MARSTON
