

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF B4089 ALCESTER ROAD, LITTLE ALNE

Warwickshire County Council has made a Temporary Traffic Order closing B4089 Alcester Road, Little Alne, from its junction with B4089 Henley Road (at the access to Pool's Barn Farm) to its junction with White House Hill, to vehicular traffic.

The closure is required to facilitate carriageway works.

The Order will commence on 1 December 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 3 December 2018.

PLEASE NOTE: The work is expected to be carried out between 08.00hrs and 17.00hrs daily however, the road will remain closed outside of these hours until the works are concluded.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF TAVERN LANE, SHOTTERY

Warwickshire County Council has made a Temporary Traffic Order closing Tavern Lane, Shottery to vehicular traffic.

The closure is required to facilitate works for a new sewer connection.

The Order will commence on 5 December 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 December 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Bell Lane, Shottery, Tavern Lane (and vice versa).

TEMPORARY CLOSURE OF WATERY LANE, SHIPSTON ON STOUR

Warwickshire County Council proposes to make a Temporary Traffic Order closing Watery Lane, Shipston on Stour to vehicular traffic.

The closure is required to allow for a safe environment for engineers to work in an underground structure.

PLEASE NOTE: The work will be carried out daily between 09.30hrs and 15.30hrs.

The Order will commence on 17 December 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 December 2018.

An alternative route will be signed and is available via: Watery Lane, Stratford Road, Station Road (and vice versa).
